HUMAN-CENTRED

Any Al-generated content, recommendations or suggestions are reviewed by the team to ensure they meet our BLC standards.

COLLABORATION, NOT REPLACEMENT

Al can support idea generation and iteration of design concepts, but our expert content developers will always be the creators of our content, using Al to enhance their capabilities, not replace them.

CONTINUOUS IMPROVEMENT AND INNOVATION

Our team are continually looking at new systems, processes, or ways to develop content. We will always aim to be aware of new developments in Al and adopt those which can improve our work whilst aligning to our commitments around ethics and responsibility.
